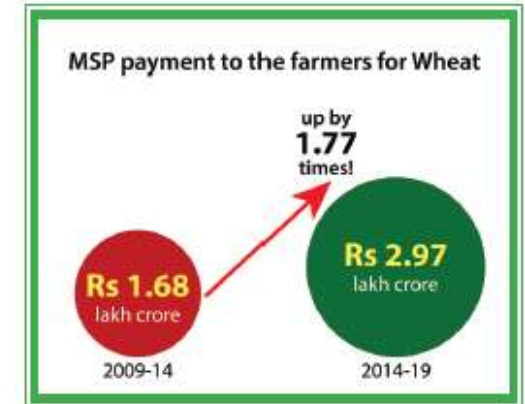
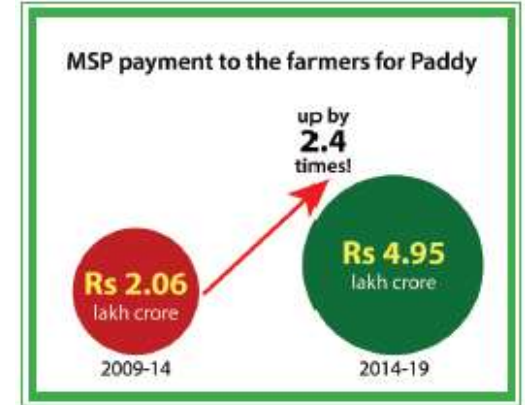

 - Mi apalrangna 2.4 chang bataniko nikna gita mana (Rs 4.95 Lakh Crores)
 - 75 chang dal aro soyabean (pulses) rangna (Rs 49,000 Crores)
 - Chang chikunga (10) bate to jetna jetna jakkalgipa bitchilrang (Besual Bitchil)
 - 1.77 chang gom mi rango bariataniko nikna gita mana (Rs 2.97 Lakh Crores)

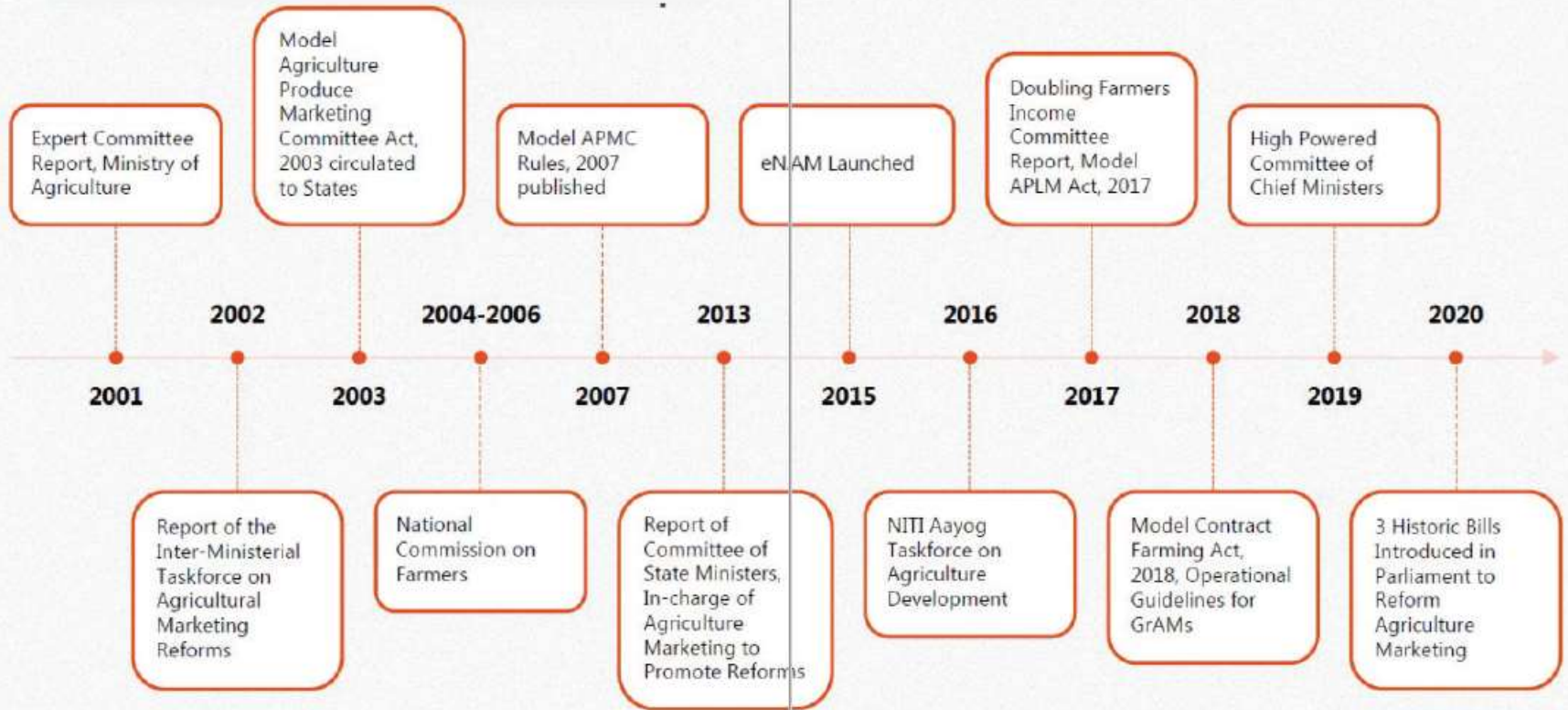
Consultation Process /Chanchirimani

- **Inter – Ministerial Task Force (2002) bazar anti chagipa ko namdapatna janapaha aro contract farming ko dakdilna didiaha.**
- **Model APMC act, 2003 agriculture marketing ko, state Government ming bakrime chanchirimaha.**
